- ** The Organization will be responsible for insuring that the Grounds are left clean and clear of all trash and extraneous materials following use, and that any materials stored at the Grounds by ERA, and used by the Organization are returned to their proper location. The Board Member overseeing access will inspect the grounds after use is concluded.
- ** Only those individuals authorized by the ERA Grounds Manager will be allowed to groom/drag the arena.

**** Additional Conditions of Use: The following restrictions do not apply if box is checked, and then approved by ERA:**

- No access to any area where animals are being contained or enclosed.
- No access to any of the outbuildings on the property, this includes the Announcer Stand above the Chute Gates, the Registration Office and the Rodeo Storage Areas.
- No climbing on or over any fencing on the property.
- When Grounds are used for parking, the Organization will provide parking guidance for organized parking, and will control the flow of vehicles and pedestrians as they enter and leave the area.
