### **ROYALTY CONTESTANT ELIGIBILITY**

- Miss Evergreen Rodeo contestants - Must be a single female between the ages of 17 and 24 years of age during her reigning year
- Evergreen Rodeo Princess contestants - Must be a single female between the ages of 14 and 17 years of age during her reigning year
- Reside within the following zip codes:80433, 80439, 80452, 80465
- Provide documented proof of age (birth certificate or driver's license)
- Currently be enrolled in an approved educational institution OR have previously obtained a high school diploma or equivalent
- Have not been previously married or pregnant
- Own or have access to a horse and transportation for required parades and rodeos

### **CONTESTANTS WILL BE JUDGED IN THE FOLLOWING AREAS DURING THE COURSE OF THE ROYALTY COMPETITION**

**Speech** - Attire: Dress or skirt with long sleeve shirt/blouse, Western felt hat and boots.

Performance: Contestants will be required to give a short speech (1-3 minutes) on a topic provided by the committee in a public forum setting. Judging will be on poise and speech content.

**Impromptu Questions** - Attire: Dress or skirt with long sleeve shirt/blouse, Western felt hat and boots.

Performance: Contestants will be required to answer questions in a public forum. Judging will be on poise and content of responses.

**Written Test** - Performance: Each contestant will be required to complete a written exam on rodeo knowledge.

**Parade** - Attire: Western jeans, Western long sleeve shirt/blouse, Western felt hat and boots.

Performance: Queen and Princess contestants will be required to ride their horse in the Evergreen Rodeo Parade. Jr Princess contestants may ride their horse with committee approval or may ride on the float with the visiting royalty.

**Appearance** - Attire: Dress or skirt with long sleeve shirt/blouse, Western felt hat and boots.

Jeans are not to be tucked into boots. Performance: Each contestant will be judged on appearance, poise, etiquette, and social interaction.

**Personal interview** - Attire: Western dress or suit, Western felt hat and boots. Performance:

Each contestant will participate in a personal interview with all the judges, where they will be asked questions on any topic from rodeo, personal views, and current events. Judging will be on poise and responses.

**Horsemanship** - Queen/Princess- Attire: Western jeans, long sleeve shirt/blouse, Western felt hat and boots. Performance: Each contestant will ride their horse and perform the pattern established and set

by the Royalty Committee/Judges. Each contestant will also be required to perform a flag run, and a "Queen's lap".

### **GENERAL INFORMATION AND RULES**

Responsibilities of the Evergreen Rodeo Royalty include learning about and promoting the Evergreen Rodeo Association, as well as the Evergreen community. Contestants are not required to own a horse but are required to provide a horse to be used during judging.

If you win the title, you will need access to a horse and trailer for traveling to different rodeos in the State of Colorado. No stallions are allowed. If for some reason, the Queen, Princess, or Jr. Princess cannot fulfill her duties, the Royalty Committee may appoint an eligible candidate to assume the title.

Contestants shall remain free of any questionable behavior relative to the issues of morality. [This includes the use of social media.] Consumption of alcohol or use of tobacco is not allowed while representing the Evergreen Rodeo Association. Use of illegal drugs or involvement in any illegal activity will not be tolerated and will be grounds for immediate disqualification.

### **OBLIGATIONS**

The newly selected royalty court shall be required to appear publicly to represent the Evergreen Rodeo Association immediately after she is crowned.

During her reigning year, attendance will be required at events during the Evergreen Rodeo weekend as well as select parades, promotional events, and outreach/volunteer opportunities within the State of Colorado.

The Queen, Princess, and Jr. Princess will be required to secure sponsorships throughout their reigning year.

### **DRESS CODE**

A felt Western hat, crown, western boots, and sash are required for all official events. Jeans are to be worn outside of boots. Current royalty must look their best while representing the Evergreen Rodeo Association. Some clothing items will be available for loan through the Royalty Closet but must be returned at the end of your reign in the same condition they were received.
